

EDII also conducted an SVEP Mentor Training for the mentors who were recently inducted in the SVEP Program. The 8-day training programme was to provide an enriched learning experience to the SVEP mentors on planning and implementation Non-Farm Interventions envisaged under the programme using the SVEP approach.







CBO training was conducted in several blocks of Maharashtra were an orientation was given on SVEP, role and responsibility of stakeholders, DPR preparation and processes, business viability, CEF disbursement process, repayment process, fund flow, monitoring tool and process etc.



In the Qazigund-Dooru Shahabad block of Jammu & Kashmir, a 3 days EDP training was conducted by the SVEP mentor where 25 entrepreneurs received training on business operations.



One of the Institute's primary objectives and successes is harnessing the rural poor latent potential via training and capacity building. In the past month, various workshops on capacity building, skill development, business plan preparation and SVEP software training were organized in states like Assam, Chhattisgarh, Madhya Pradesh, Punjab, Jammu & Kashmir, Uttar Pradesh, and West Bengal. 


CBO training was conducted among the community members in Jaspur, Joshimath & Sahaspur block of Uttarakhand where 876 members were trained.




# १५ महिलांना व्यवसाय प्रशिक्षण
