Bengaluru: The Entrepreneurship Development Institute of India (EDII) established in 1983 amidst apprehensions about entrepreneurship as a conscious career option, is today the foremost National Resource Institute in Entrepreneurship Education, Training, Research, Institution Building, MSME Growth, Innovations and Incubation.
