EDII kick starts its annual startup summit 'Empresario 2024' on Tech Innovations

Ahmedabad, March 7, 2023: The Entrepreneurship Development Institute of India (EDII), on Thursday, kick started its annual startup summit and entrepreneurship festival— Empresario 2024.
